## Echoes Sessional Billing

- Echoes bills per chargeable daily session in the calendar month
- Bills will vary dependent on the number of sessions your child was scheduled to attend that calendar month. Therefore parents will need to check their invoice each month to pay the correct amount.
- The nursery is closed on the following days and the sessions are not charged
  - England Bank Holidays
  - Christmas close down week
- All child absences will be chargeable e.g. due to illnesses, family holiday and appointments
- The All Inclusive rate is based on the 12 hour daily session during which you are welcome to drop and collect at your discretion with no additional charge. Collections after 18.30 must be notified in writing and agreed two weeks before.

## Fees Due Date

- Fees are payable monthly in advance.
- Invoices will be sent by email on or around 26<sup>th</sup> of each month for the fees for the coming month. e.g. invoice 26<sup>th</sup> February for sessions in March.
- Fees are due by the 1<sup>st</sup> of the month.
- Fees can be paid by standing order, from the Tax Free Childcare scheme or voucher schemes or a mixture of all.
- Parents are asked to check their method of payment has been successfully sent from their account every month on 02<sup>nd</sup> to avoid late payment
- Late fees charges will apply for fees not received by the 5<sup>th</sup> of the month
- Late fees will be charged for sessions after 6.30pm not advised in advance

## Stretched Funding

- The funding offered and advertised by the government is for Term Time Only weeks – which is 38. Therefore, the advertised 30 hours funding per week is only for the 38 term weeks
- As Echoes is open 51 weeks of the year we take the total hours per year offered by the government and split them over the 51 weeks of the year.
- This means that you get the total government funding but equally spread over the 51 weeks we are open
- The Department of Education set the number of hours that can be claimed based on the number of days per week, please refer to the Funding Allocation section below.

## Tax Free Childcare

Did you know that the government offers tax free childcare to eligible families in addition to the funding schemes and that Echoes Childcare is registered to receive payments from the government's Tax Free Childcare Scheme.

You can apply for Tax Free Childcare even if your child receives funding.

### What does that mean?

It could mean the government pays you up to **£2,000** per child per year for use against your childcare costs.

### How does it work?

You pay money into a Tax-Free childcare account and for every **£8** you pay in, the government will automatically add **£2**, up to **£2,000** per child per year (or £4,000 for disabled children).

This money can be used to pay your childcare provider directly. You will have **apply** as we can't do that for you but we do accept payments from tax-free child care accounts.

### **Below is an example of the calculation of how much to deposit in the Tax Free Childcare account**

If your Echoes monthly fees are £100

- $£100 * 0.80 = £80.00$  this is the amount you deposit in the scheme
- $£100 * 0.20 = £20.00$  this is the amount the government will automatically top up (up to £500 per 3 months)

Therefore, there will be £100 in your Tax Free Childcare account to pay our £100 fees but you have only had to pay in £80.00.

Parents need to ensure that payments to Echoes Childcare are successful from the Tax Free Childcare account as bank holidays / weekends / insufficient funds can mean payments are not made.
